PART I – GENERAL INFORMATION

1. **Last date and time for depositing the Bids:** The last date/time of bid submission is **23 Jul 25 at 1130 Hrs.** The sealed Bids (Technical and Commercial) should be deposited in the tender box by the due date and time. The responsibility to ensure this lies with the Bidder. The Bids can also be **sent by registered post/courier/speed post.** Late tender will not be considered and No responsibility will be taken for postal delay or non-delivery/non-receipt of bid documents

2. **Manner of submission of Bids:** Sealed quotations addressed to **The Honorary Secretary General, Subroto Mukerjee Sports Education Society, Air Force Sports Control Board, C/O Air Force Station New Delhi Race Course-110003** and should be dropped in Tender Box marked

Tender Box will be kept near the main guard room at **Air Force Station New Delhi, Race Course, New Delhi – 110003** or be sent by registered post/courier/speed post. Bids sent by **FAX/Email** will not be considered.

3. **Location of the Tender Box:** **Main Guard Room, Air Force Station New Delhi, Race Course New Delhi – 110003.** On the date of opening only those Bids that are found in the tender box kept in the Main Guard Room will be opened. Bids dropped in any other Tender Box will be rendered invalid. **Bids received after due date/time specified will be returned to the sender of "Freight to Pay" basis.**

4. **Forwarding of Bids:** Bids should be forwarded by Bidders under their original memo / letter pad giving their complete current **postal and email address, contact and Fax number of their office.** Bidders in addition to stating in their offer the correct legal **communication address** on which the supply Order / Purchase Order is to be placed and dispatched, are also to give the details of their Bankers with SWIFT code and Account Number. The Techno-Commercial bid will consist of both Technical bid (**Envelop-1**) and Commercial bid (**Envelop-2**) enclosed in **Single Envelop.**

5. **Pre-Bid Conference.** In order to facilitate the vendors to clarify any queries with regard to the contents of the RFP and to specify the requirement of user, a pre-bid meeting will be conducted at Buyer's premises on **15 Jul 25 at 1530 Hrs.**

6. **Clarification Regarding Contents of the RFP.** A prospective bidder who requires clarification regarding the contents of the bidding documents shall notify to the Buyer in writing about the clarifications sought not later than **4 days** prior to the date of opening of the Bids or during pre-bid meeting.

7. **Modification and Withdrawal of Bids.** The Bidder may modify or withdraw his bid after submission provided that the written notice of modification or withdrawal is received by the Buyer prior to deadline prescribed for submission of bids. A withdrawal notice may be sent by FAX but it should be followed by an ink signed confirmation copy to be sent by post and such signed confirmation should reach the purchaser not later than the deadline for submission of bids. No bid should be modified after the deadline for submission of bids and expiration of the period of bids validity specified. Withdrawal of a bid during the period will result in bidder's forfeiture of bid security and /or ban on issuance of further RFP's as per the decision of Competent Authority.

8. **Clarification Regarding Contents of the Bids.** During evaluation and comparison of bids, the Buyer may, at its discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. **No post bid clarification on the initiative of the bidder will be entertained**

9. **Time and date of opening of Technical & Commercial Bids: As per Critical Date Sheet (Part-I, Para-15 of RFP)** (If due to any exigency, the due date for opening of the Bids is declared a closed holiday, the Bids will be opened on the next working day at the same time or on any other day/time, as intimated by the Buyer).

10. **Place of Opening of the Bids: Office of Honorary Secretary General, Subroto Mukerjee Sports Education Society, C/o Air Force Sports Control Board, Air Force Station New Delhi Race Course-110003.** The Bidder may depute their accredited representatives, duly authorized in writing, to attend the opening of Bids on the due date and time. **Details of the accredited representatives are to be forwarded to this Office by Fax** (followed by an ink signed copy) well before the due date of the tender opening, for originator to facilitated security clearance and entry to the office of Honorary Secretary General, SMSES. Rates and important commercial clauses quoted by all Bidders will be read out in the presence of the accredited representatives of all the Bidders. It may be noted that this event will not be postponed due to non-presence of your

representative (s). Bidders are to ensure that their accredited representatives are in possession of copy of advance intimation letter sent to Honorary Secretary General SMSES, authorizing them to participate in the tender opening. Only authorized accredited Indian Agent/ Representative would be permitted to participate in the tender opening process. Prospective bidders are, therefore, advised to complete the requisite formalities as covered in the GoI / MoD instructions. (Details available in MoD official web sites, namely, <http://www.mod.nic.in> under heading new circular and notification for nomination of Indian Representative/ Agent.

11. **Bids are liable to be rejected for the following reasons:** Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection or ban on issuance of further RFP's. Conditional tender can be rejected.

12. **Validity of Bids.** The Bids should remain valid for **120 days** from the date of opening of tenders.

13. **Cost of the Tender/Tender Fee.** The tender document/RFP will carry a Price of **Rs 500/- (Rupees Five Hundred only)**. Demand draft in favour of "**Honorary Secretary General Subroto Murkerjee Sports Education Society**", Race Course, New Delhi or **Cash deposit receipt** in the **A/C No.90552010001695 (Canara Bank 19055-South block branch)** is to be attached along with the Bid. This amount is non-refundable.

14. **Earnest Money Deposit:** Bidders are required to submit Earnest Money Deposit (EMD) for an amount of **Rs 3,90,000/- (Rupees Three Lakh Ninety thousand only)** along with their bids. The EMD may be submitted in the form of an Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the public sector banks or a private sector bank authorised to conduct government business (viz ICICI Bank Ltd/Axis Bank Ltd/HDFC Bank Ltd only) as per Form DPM-13 (Available in MoD website and can be provide on request). Demand draft & Banker's cheque should be drawn in favour of "**Honorary Secretary General Subroto Murkerjee Sports Education Society**", Race Course, New Delhi. EMD is to remain valid for a period of forty-five days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The Bid Security of the successful bidder would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. EMD is not required to be submitted by those Bidders who are registered with the Central Purchase Organization (e.g. DGS&D), National Small Industries Corporation (NSIC), DGQA or similar procurement organisations of Ministries of the Government of India for the same item/ range of products, goods or services for which the tenders have been issued. Firms registered with units/Establishments of Army, Air Force, Navy or DRDO Labs which do not qualify to be part of Central Purchase Organisations will not be exempted from EMD. The bidder is required to attach the copy of proof for exemption of EMD with their technical offer. The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of their tender.

14. **Unsolicited bids:** Will be considered on case to case basis on the order of the competent financial authority.

PART II- ESSENTIAL DETAILS OF ITEMS/SERVICES REQUIRED

1. **Schedule of Requirements:** - As tabulated below and compliance sheet is attached as Appendix A: -

1.1.	Quadra Occupancy (Four players in each Room)	3 Star and above	Details placed at Appendix 'B' & 'C'
1.2.	Double Occupancy (Two person in each room)	3 Star and above	Details placed at Appendix 'B' & 'C'

2. **Period of services required.** The accommodation is required for the period mentioned in Appendix B & Appendix C of this RFP. Approximate number of Rooms and period are mentioned above. However, these numbers may go up or down depending on the confirmation /performance of the teams. The period of stay may also vary as the losing team will leave in a phased manner. Payment will be made on actual occupancy basis of Rooms only. i.e. time of arrival of team and departure of teams.

3. **Technical Details/Specification / QR.** Special Terms and Conditions/Technical detail / specifications/QR required for Hiring of Accommodation are given succeeding paragraphs: -

- 3.1. **Standard of Hotel.** Standard accommodation in 3/4 star and above rated Hotels are required to for Junior players and coaches of Indian and Foreign teams near to the venues. Tournament venues are appended below: -

- 3.1.1. Dr.BR Ambedkar Football Stadium, New Delhi
- 3.1.2. GD Goenka School, Gurugram
- 3.1.3. Pinto Park, Palam
- 3.1.4. AF Stn Rajokri

- 3.2. **Star Rating.** All rooms provided for Indian and Foreign Players/Coaches must have 3/4 Star and above rating. Preference would be given to single chain of hotels with 3/4 Star rating.

- 3.3. **Facilities Required.**

- 3.3.1. Room should be Air Conditioned.
- 3.3.2. Three meals per day in the hotel only.

- 3.3.3. Morning Tea/Coffee/Milk with biscuits (Morning & Evening)
- 3.3.4. LCD/LED TV in Rooms
- 3.3.5. 24 Hrs hot and cold water running.
- 3.3.6. 24x7 water and electricity facility
- 3.3.7. Must have attached bathroom.
- 3.3.8. Must have restaurants
- 3.3.9. Must have Medical services/first aid/Doctor on Call in case of emergency.
- 3.3.10. Must have air conditioned Banquet hall (capacity of 300 persons)
- 3.3.11. Must have dedicated area for drying cloths/cloth stand.
- 3.3.12. Washing Machine with attendant for dry/washing the cloth.

3.4. **Separate Hotels.** Separate hotels/proper segregation of floors are to be provided for girls and boys.

3.5. **Number of Hotel in which accommodations are earmarked with respect to Chain of Hotels:** Chain of Hotels participating in the bidding should earmark less than three hotels only for providing accommodation.

3.6. **Food license.** Prospective bidder should have valid Food License.

3.7. **Meals.** If the bidder has more than one property, same meals are to be provided in all properties. No deviation in meals is expected. Meals are to be provided in the form of buffet system (unlimited) at the restaurants or Banquet Hall. Proposed Meals are attached as **Appendix 'E'**.

3.7.1. Purified RO drinking water as per requirement of the players are to be provided without any extra charges.

3.7.2. Moring tea/and evening tea with refreshment should be provided to each and every player/supporting staff.

3.7.3. In case any player is injured or has fallen sick, the food should be provided in his/her Room.

3.8.4. Food preparation area (kitchen) should be hygienic and should be available for inspection to Organizing Committee at any point of time.

3.9.5. All the meals served are to be preserved for 24 Hrs for testing, if required.

3.8. **Separate hospitality Desk.** For better management, a separate hospitality desk must be set up by the hotel for liaison with Organizing Committee and to facilitate check in check out of players/teams.

3.9. **Image of the Rooms.** The firm has to attach at least three actual photographs of room in each category which are to be allotted for the players/ coaches/Dignitaries. Based on the image provided, the organizing committee may visit the hotel and evaluate the rooms at any point of time. Three photographs of dining hall /restaurants should also be attached.

3.10. **Book Out.** Players are not allowed to Book out after 2200 Hr without the specific permission of Coach/Authority.

3.11. **Housekeeping:** Daily Housekeeping of the room should be ensured. Toilets are to be sanitized before each check in and check out. Bed sheets and pillow covers are to be

changed on daily basis. Toiletries (Soap, Shampoo & Towel) for each occupant need to be provided.

3.12. **Check –in & Out.** Flexibility during Check-in & Check out.

3.13. **Security.** CCTV recordings is mandatory and to be shown on demand to the Organizing Committee. Security guards to be available 24x 7 and should be at entry gates.

3.14. **Parking.** Sufficient parking space of vehicles/buses used for transportation should be made available near the accommodation area.

3.15. **Entertainment.** Entertainment shows to be hosted by vendor daily during evening hours at around 1800 to 2000 Hr.

3.16. **Refreshment.** Vendor should provide refreshment to the players on all matches days to venue Managers (refreshment like Muffin, Sandwich and drink). NO additional payment will be made for provisioning of refreshment during matches.

3.17. **Additional Room.** One additional Room needs to be provided by the vendor free of cost for the venue manager and his team from 17 Aug to 25 Sep 25.

4. **Past project experience:** Past project experience of (20% of contract value) similar service to any Govt/Semi Govt service /reputed civil organization is a pre-requisite for prospective bidder.

5. **Bidder turn over.** Minimum average turnover of the bidder participating in this bid should be Rs 10 Crores in the last three Years.

6. **Documents.** Copies of the following documents are to be submitted along with the bids: -

7. **Delivery Period.** As per the Schedule given in **Appendix B & C of RFP**. The accommodations have to be provided at an urgent notice of not less than 24 Hrs telephonically /by email/through supply order.

PART III - STANDARDS CONDITIONS OF RFP

1. The Bidder is also required to give confirmation of their acceptance of the under mentioned Standard Conditions of the Request for Proposal mentioned below which will automatically be considered as part of the Contract concluded with the successful Bidder (i.e. Seller in the Contract), as selected by the Buyer. Failure to do so may result in rejection of the Bid submitted by the Bidder.

2. **Law:** The contract shall be considered and made in accordance with the laws of the Republic of India. The contract shall be governed by and interpreted in accordance with the laws of Republic of India.

3. **Effective Date of the Contract:** The contract shall come into effect on the date of issue of acceptance of Bid/ Tender by the buyer and shall remain valid until the completion of the obligations of the parties under the contract. The deliveries, supplies and performance of the service shall commence from the effective date of the contract.

4. **Arbitration:** All disputed or differences arising out of or in connection with the contract shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the contract or relating to construction or performance, which cannot be settled amicable, may be resolved through arbitration. The standard clause of arbitration is as per Forms DPM-7, DPM-8 and DPM-9 (Available in MoD website: <http://www.mod.nic.in>).

5. **Penalty for use of Undue influence:** The Seller undertakes that he has not given, offered or promised to give, directly or indirectly, any gift, consideration, reward, commission, fees, brokerage or inducement to any person in service of the Buyer or otherwise in procuring the Contract or forbearing to do or for having done or forborne to do any act in relation to the obtaining or execution of the present Contract or any other Contract with the Government of India for showing or forbearing to show favor or disfavor to any person in relation to the present Contract or any other Contract with the Government of India. Any breach of the aforesaid undertaking by the Seller or any one employed by him or acting on his behalf (whether with or without the knowledge of the Seller) or the commission of any offers by the Seller or anyone employed by him or acting on his behalf, as defined in Chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act, 1988 or any other Act enacted for the prevention of corruption shall entitle the Buyer to cancel the Contract and all or any other Contract with the Seller and recover from the Seller the amount of any loss arising from such cancellation. A decision of the Buyer or his nominee to the effect that a breach of the undertaking had been committed shall be final and binding on the Seller. Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the Seller towards any officer / employee of the Buyer or to any other person in a position to influence any officer / employee of the Buyer for showing any favor in relation to this or any other Contract, shall render the Seller to such liability/ penalty as the Buyer may deem proper, including but not limited to termination of the Contract, imposition of penal damages, forfeiture of the Bank Guarantee and refund of the amounts paid by the Buyer.

6. **Agents / Agency Commission:** The Seller confirms and declares to the Buyer that the Seller is the original manufacturer of the stores/provider of the services referred to this Contract and has not engaged any individual or firm, whether Indian or foreign whatsoever, to intercede, facilitate or in any way to recommend to the Government of India or any of its functionaries whether officially or unofficially, to the award of the Contract to the Seller, nor has any amount been paid, promised or

intended to be paid to any such individual or firm in respect of any such intercession, facilitation or recommendation. The Seller agrees that if it is established at any time to the satisfaction of the Buyer that the present declaration is in any way incorrect or if at a later stage it is discovered by the Buyer that the Seller has engaged any such individual/firm, and paid or intended to pay any amount, gift, reward, fees, commission or consideration to such person, party, firm or institution, whether before or after the signing of this Contract, the Seller will be liable to refund that amount to the Buyer. The Seller will also be debarred from entering into any Contract with the Government of India for a minimum period of five years. The Buyer will also have a right to consider cancellation of the Contract either wholly or in part, without any entitlement or compensation to the Seller who shall in such an event be liable to refund all payments made by the Buyer in terms of the contract along with interest at rate of 2% per annum above LIBOR rate. The Buyer will also have the right to recover any such amount from any Contracts concluded earlier with the Government of India.

7. Access to Books of Accounts: In case it is found to the satisfaction of the Buyer that the Seller has engaged an Agent or paid commission or influenced any person to obtain the Contract as described in clauses relating to Agents/Agency Commission and penalty for use of undue influence, the Seller, on a specific request of the Buyer, shall provide necessary information/ inspection of the relevant financial documents/information.

8. Non-disclosure of contract documents: Except with the written consent of the Buyer/ Seller, other party shall not disclose the Contract or any provision, specification, plan, design, pattern, sample or information thereof to any third party.

9. Liquidated Damages: In the event of the Seller's failure to submit the Bonds, Guarantees and Documents, supply the stores/goods and installation of items, etc. as specified in this contract, the Buyer may, at his discretion, withhold any payment until the completion of the contract. The **BUYER** may also deduct from the **SELLER** as agreed, liquidated damages to the sum of 0.5% of the contract price of the delayed/undelivered stores/services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores/services.

10. Termination of Contract: The Buyer shall have the right to terminate this Supply Order in part or in full in any of the following cases: -

10.1.1. The accommodation services are delayed for causes not attributable to Force majeure for more than 4 Hours after the scheduled date of delivery.

10.1.2. The Supplier is declared bankrupt or insolvent.

10.1.3. If the supplier, in the judgment of the Buyer, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

10.1.4. "Corrupt practice" means the offering, giving, receiving or soliciting if anything of value to influence the action of a public official in the procurement process or in contract execution. "Fraudulent Practice" means misrepresentation of facts in order to influence the procurement process or the execution of a contract to the detriment of the Buyer, and includes collusive practice among Bidders (prior to or after bid submission)

10.1.5. The Buyer has noticed that the Seller has utilized the services of any Indian/Foreign agent in getting this contract and paid any commission to such individual/company etc.

10.1.6. As per decision of the Organizing Committee.

11. **Notices:** Any notice required or permitted by the Supply Order shall be written in the English language and may be delivered personally or may be sent by FAX or registered pre-paid mail/airmail, addressed to the last known address of the party to whom it is sent.

12. **Transfer and Subletting:** The Seller has no right to give, bargain, sell, assign or sublet or otherwise dispose of the Supply Order or any part thereof, as well as to give or to let a third party take benefit or advantage of the present Supply Order or any part thereof.

13. **Amendments:** No provision of present Contract shall be changed or modified in any way (including this provision) either in whole or in part except by an instrument in writing made after the date of this Contract and signed on behalf of both the parties and which expressly states to amend the present Contract.

14. **Taxes and Duties:**

14.1. **General/GST**

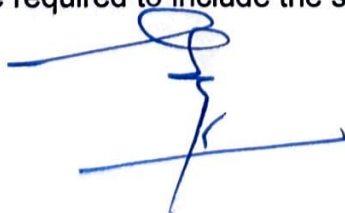
